

**BALDWIN TOWNSHIP MEETING
OATH OF OFFICE & REORGANIZATION OF TOWN BOARD**

March 16, 2011

Present – Supervisors Larry Handshoe, Jeff Holm, Tom Rush and Jay Swanson.

Call to Order – The March 16, 2011 Oath of Office and Reorganization of the Town Board meeting was called to order by Chairman Jeff Holm at 7:03 pm

Pledge of Allegiance – All present recited the Pledge of Allegiance.

Oath of Office (Supervisor “B”) – The Clerk/Treasurer administered the Oath of Office to Randy Atwood, the winning candidate for Supervisor “B”.

Oath of Office (Supervisor “C”) – The Clerk/Treasurer administered the Oath of Office to Kimberly Good, the winning candidate for Supervisor “C”.

Reorganization of Town Board – Swanson thanked Jeff Holm for 3 years of service and stated that Holm left Baldwin a better place.

Select Town Board Chair – Handshoe nominated Swanson with Rush seconding the nomination. Handshoe/Rush unanimous to close the nominations. Swanson accepted the nomination. Handshoe/Rush unanimous approving Jay Swanson as chairman.

Select Town Board Vice-Chair – Handshoe/Rush unanimous to open nominations. Handshoe nominated Rush with Kimberly Good seconding the motion. Handshoe/Good unanimous to close the nominations. Rush accepted the nomination. Good/Handshoe unanimous approving Tom Rush as vice-chairman.

Review Town of Baldwin Organization List – The board reviewed the organization list and changes were made. The item will be placed on the April 4, 2011 town board regular meeting agenda for final approval of the changes.

Confirm Transfer of Town Records to Newly Elected Officers – The clerk/treasurer stated that the record transfers were complete.

Approve/Disapprove Compensation Rates for Town Officers – A motion by Handshoe/Good to increase the supervisor monthly base pay to \$50.00, meeting pay to \$50.00 and hourly pay to \$15.00. Upon voice vote the motion carried with Handshoe and Good voting in favor, Swanson opposed and Rush and Atwood no voice vote. The veterinarian expense rate was changed from \$50.00/cat and \$60.00/dog.

Review Employee Safety Program (AWAIR) – The board reviewed the current AWAIR program in place.

Review Town Ordinance & Resolution Book – The board reviewed the town ordinance and resolution books.

Approve/Disapprove Official Township Newspaper – Handshoe/Good unanimous to approve the Princeton Union Eagle as the official township newspaper.


Approve/Disapprove Designated Legal Posting Areas – Handshoe/Rush unanimous to designate the legal posting areas as the town hall and Marv's True Value.
