**RESOLUTION # 2003-06
AGREEMENT FOR DIVISION OF ROAD PROJECT
RESPONSIBILITIES AND PAYMENT FOR 96TH STREET**

This agreement is hereby entered into this 6TH day of OCTOBER, 2003 by and between the Town Board of Supervisors of Baldwin Township, Sherburne County, Minnesota and the Town Board of Supervisors of Spencer Brook Township, Isanti County, Minnesota.

WHEREAS, Baldwin Township and Spencer Brook Township share the following described town line road: 96th Street.

WHEREAS, Minnesota Statute §164.12 directs town boards to divide town line roads and enter into an agreement for the maintenance of those roads;

NOW, THEREFORE, in consideration of the mutual promises and benefits that each party shall derive herefrom, Baldwin Township and Spencer Brook Township hereby enter into this agreement for the division of rebuilding responsibilities for the above described town line road:

340 feet of 96th Street located approximately 200 feet north of 285 ½ Avenue, Laylak's 2nd Addition, Baldwin Township.

Baldwin Township shall pay for rebuilding and paving the following described portion of the line road:

340 feet west of centerline on 96th Street approximately 200 feet north of 285 ½ Avenue, Baldwin Township.

Spencer Brook Township shall pay for rebuilding and paving the following described portion of the line road:

340 feet east of centerline on 96th Street approximately 200 feet north of 285 ½ Avenue, Baldwin Township.

Construction Cost \$11,870.00
 Paving Cost 3,395.00
 TOTAL \$15,265.00

COST TO BALDWIN TOWNSHIP: \$7,632.50
COST TO SPENCER BROOK TOWNSHIP: \$7,632.50

AMENDMENTS

Any alterations, amendments, deletions and waivers of the provisions of this agreement shall be valid only when reduced to writing and duly signed by each Township.

ENTIRE AGREEMENT

It is understood and agreed that the entire agreement of the parties is contained herein and that this agreement supersedes all oral agreements and negotiations between the parties relating to the subject matter hereof.
